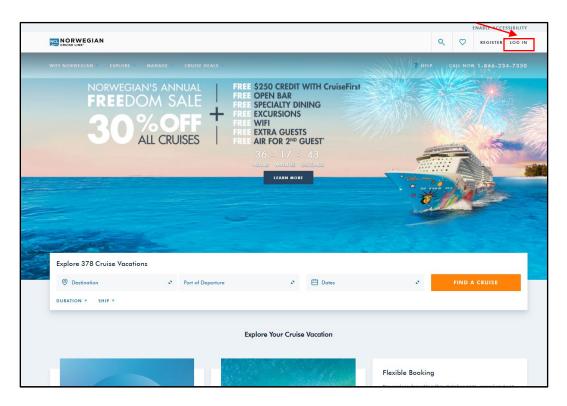
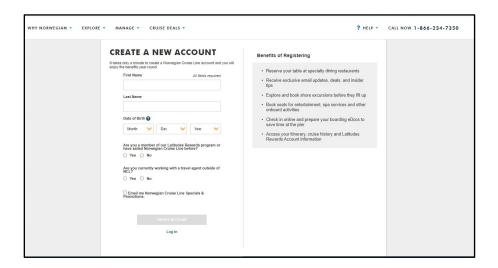
- 1.0 When a guest arrives to our website via www.ncl.com, they will need to do one of two things.

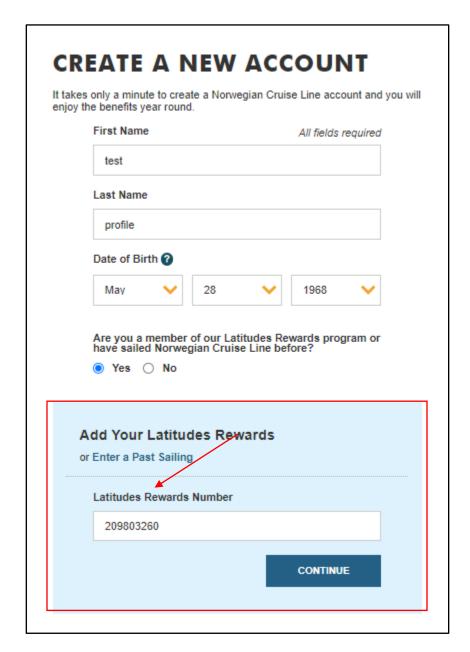

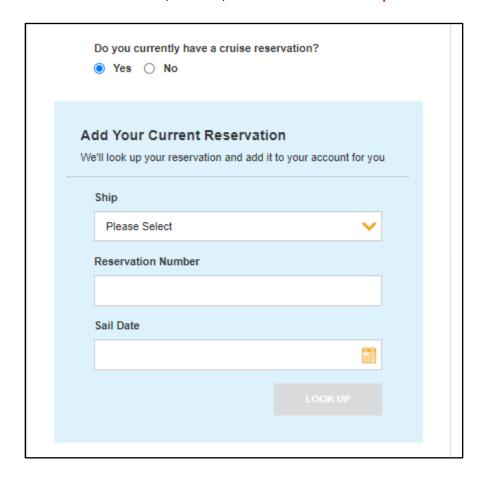

- ➤ When "Yes" is selected for the second question, the guest will need to the select ship name, enter their reservation number, sail date, and then click on "Look Up".



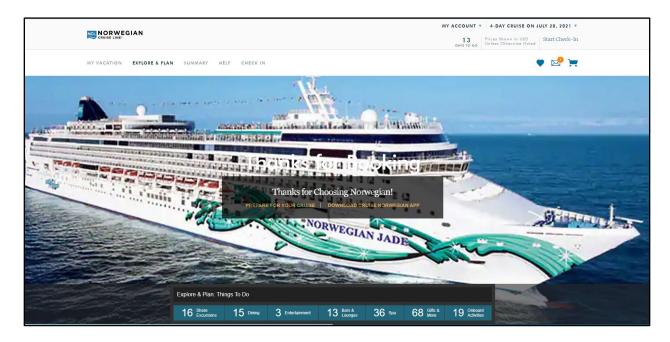

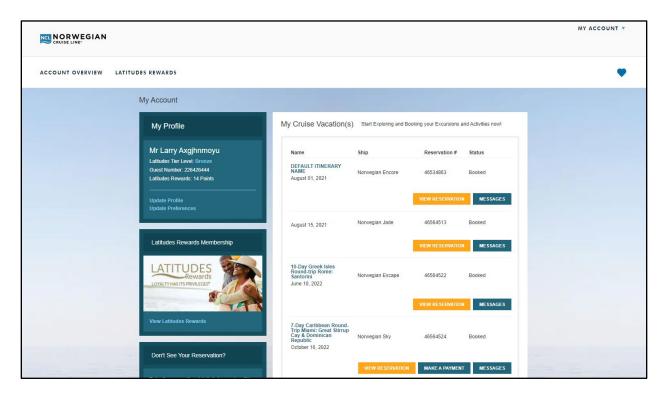

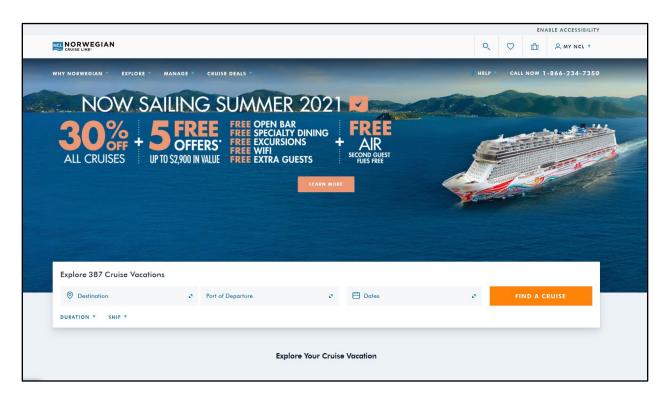
2.0 - After the guest has logged into "My NCL", they will land on the "My Vacation" page if they have a current reservation.



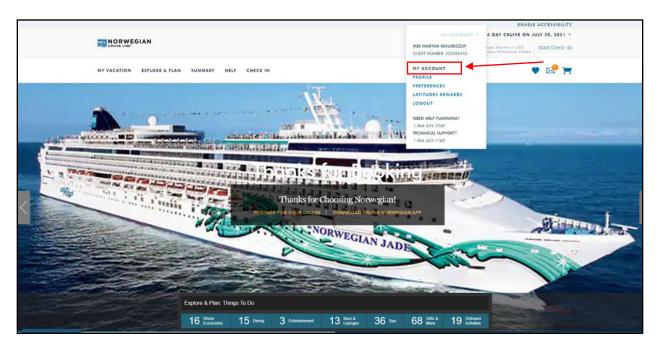
If they have multiple reservations, they will land on the "My Account" page.



If they have no reservation, then they will land on the regular home page and will be able to shop for a cruise.

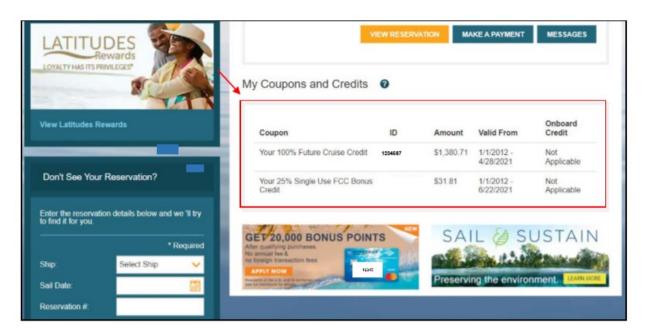


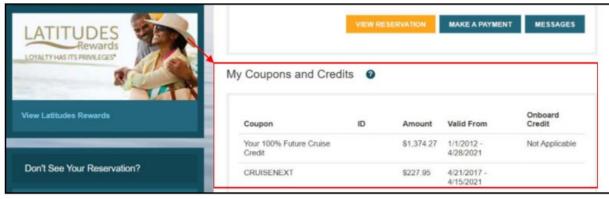

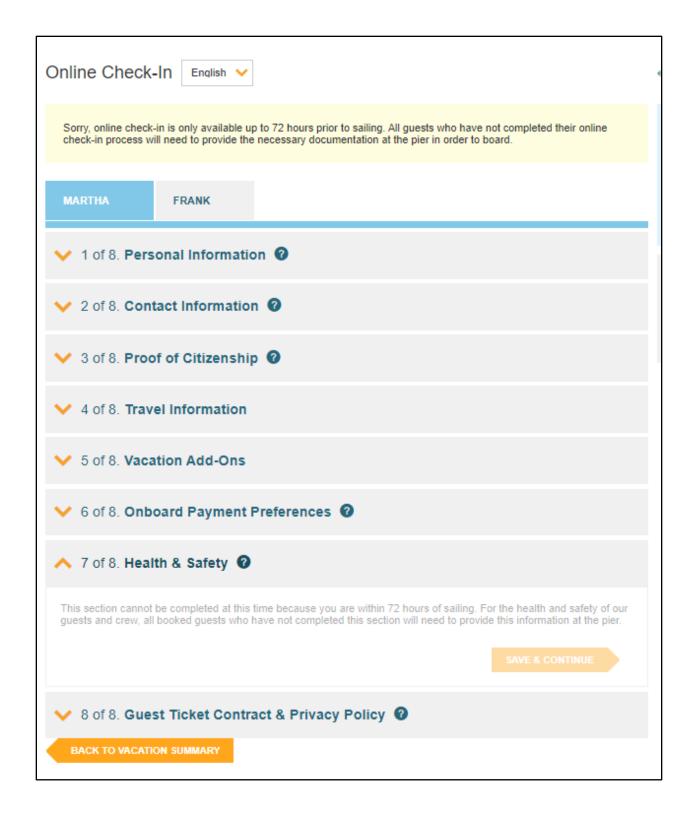


5.0 - Online Check-In

From the "My Vacation" page, the guest can access their Online Check-in by clicking on the "Check-in" tab.

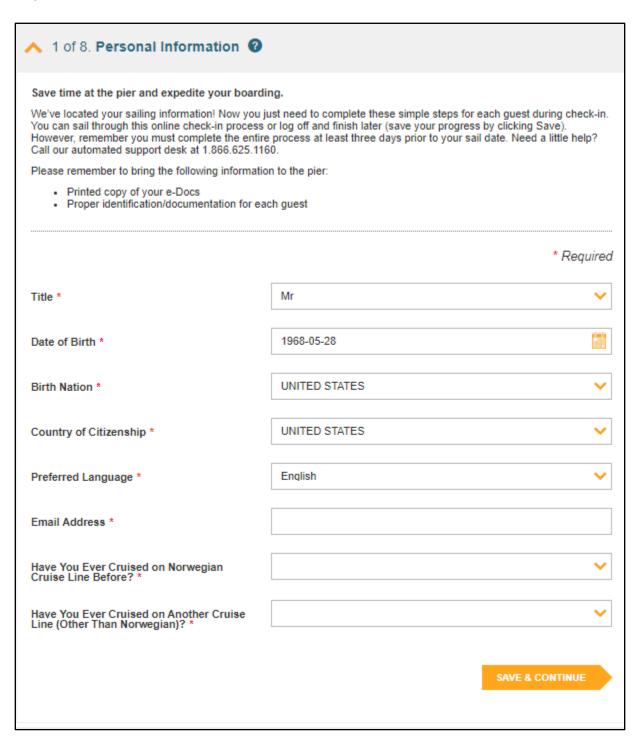
